Note: Preference shall be given to youth groups and cooperatives with experience in food processing from the six Eastern Dzongkhags of Mongar, Lhuentse, Tashigang, Tashiyangtse, Pemagatshel and S/Jongkhar. In case of no applicants, the same will be floated for aspiring private individuals/entrepreneurs. There will be a nominal lease rate and the cereal processing plant will be leased out for 3 years. The lease tenure may be extended for another term, subject to fulfillment of the set criteria.
