



- 2. The rate should be quoted as 'per' sample with the parameters given above.
- 3. The Bidder (s) shall enclose a copy of valid trade license, tax clearance certificate along with its bid.
- 4. The rates quoted shall not be subject to change for the duration of 24 hours after the scheduled opening of the bid.
- 5. Conditional quotations entailing an increase of rate/price at the time of nutrition profiling test due to increase in price associated to market force or offering alternative test referral to another lab shall not be accepted.
- 6. The nutrition profiling test work should be completed within 45 days after the receipt of the work order and test samples.
- 7. All rates should be mentioned in our local currency and should be inclusive of all incidental charges.
- 8. Payment shall be made only after availing the service and only upon submission of duly verified results of the test.
- 9. The bidder should have a fully established food testing laboratory with ISO/IEC 17025 certification and enclosed along with the bid.
- 10. The procuring agency reserves the right to award to the laboratory whoever found deemed fit by the Tender Evaluation committee.
- 11. Bids shall be **rejected**, or bidders shall be **debarred** from participating in the bidding process if they are found involved in any form of corruption or in collusion with the client.
- 12. All the other terms and conditions shall remain the same as specified in the bidding documents or PRR2023.
